The Finance Committee, 7th meeting of Indian Institute of Information Technology, Agartala was held on May 08, 2026 at 10:30 am through hybrid mode.

The Chairperson presided over the meeting and welcomed all members of the Finance Committee and greeted them for making it convenient to attend the fourth meeting of Finance Committee of IIIT Agartala.

The Chairperson invited the Director of IIIT Agartala to initiate discussion on Agenda items. The Director invited the Mentor Registrar, IIIT Agartala to place agenda to the Finance Committee for discussion and decision. The Agenda Items were placed by the Mentor Registrar, IIIT Agartala.

Item No. 7.1 :

To confirm the minutes of 6th Finance Committee Meeting, IIIT Agartala held on 9th October, 2025.

The comments as received from MoE were placed before the Finance Committee where in it was stated that no communication for 6th Finance Committee was received by MoE. It was intimated that the agenda for 6th Finance Committee was mailed to MoE on 29th September

2025 to mail Id anil.k35@gov.in followed by mail containing agenda and notification on 9th October 2025 to mail id m.kumar70@nic.in. The minutes of 6th Finance Committee were confirmed by the Finance Committee.

Item No. 7.2: **Actions taken on the decision of the 6th Meeting of Finance Committee, IIIT Agartala.**

The Finance Committee noted the action taken report.

Item No. 7.3: **To consider the Separate Audit Report of the Office of the Director General of Audit (Central), Kolkata along with the Annual Accounts of the Indian Institute of Information Technology, Agartala for the financial year 2024-25**

The Secretary covered the aspects related to the audit observations in the SAR. The Committee approved the SAR and recommended it to be placed before BoG for consideration.

Item No. 7.4: **Consideration amounting Rs.2.5 Cr under FDP as released by the MoE, Govt. of India.**

The Finance Committee noted and recommended it to be placed before BoG for consideration.

Item No. 7.5: **To consider the issue related to Fixed Deposit (FD) renewal.**

The Finance Committee noted the information.

Item No. 7.6: **Any other item with the permission from Chair.**

Item No. 7.6.1: **To consider the allotment/ deposit of funds for the work of (i) construction of new campus of IIITA at Mohanpur and (ii) renovation and refurbishing of existing old KV Buildings at NIT Agartala campus for IIIT Agartala.**

The Finance Committee ratified the approval as accorded by the Chairperson w.r.t. encashment of current FDs of Rs. 24 Crore, FDs amounting to Rs. 13 Crore (Rs. 13.00 Crores + Rs. 3,44,80,700.00) to be dissolved to transfer the amount to CPWD for aforesaid works.

Additional Points:-

The Director, IIIT Agartala brought to the notice of the Finance Committee requirement of remittance of balances of grant by Central, State Government and Industry partners.

Smt. R. Mythili of MoE confirmed that the same will be processed in the Ministry for an early release. Shri Animesh Debbarma of State Government commented the exact requirement for the current year be intimated based on the expenditure pattern for its consideration & release.

Smt. Sushma Purty of ONGC stated that as per records available with ONGC an amount of Rs. 3 Crore is to be paid against proposed amount of Rs. 4.23 Crore, which is based on 2013 MoU as signed by ONGC. Any further correspondence available on the fund requirement of Rs. 4.23 Crore ^{be} shared with ONGC for its consideration.

The meeting ended with the vote of thanks to the Chair.
